

## **ADAMS COUNTY DRUG COURT ELIGIBILITY CHECKLIST FOR DRUG COURT**

You have expressed an interest in the Adams County Drug Court. To be considered, you shall not be charged with or convicted of certain crimes.

If you answer "YES" to any of the following questions, you do not meet the eligibility criteria for Adams County Drug Court and will not be considered by the team for acceptance to the Adams County Drug Court.

1. \_\_\_\_\_ I am charged with a forcible felony or I have been previously convicted of a forcible felony (as defined in IC 35-41-1-11).
2. \_\_\_\_\_ I am charged with a crime of violence or I have been previously convicted of a crime of violence (as defined in IC 35-50-1-2).
3. \_\_\_\_\_ I am charged with a sex crime or I have been previously convicted of a sex crime.
4. \_\_\_\_\_ I am charged with a crime involving possession of a firearm or a destructive weapon, or I have previously been convicted of a crime involving possession of a firearm or destructive weapon.
5. \_\_\_\_\_ I am charged with an offense related to the operation of a vehicle while intoxicated under I.C. 9-30-5 or operation of a motorboat while intoxicated under I.C. 35-46-9.
6. \_\_\_\_\_ I am charged with an offense related to racketeering activity I.C. 35-45-6-2.

If you answer "YES" to any of the following questions, you do not meet the eligibility criteria for Adams County Drug Court and will not be considered by the team for acceptance to the Adams County Drug Court, unless the prosecutor consents to a referral.

If you answer "YES" to any of the following questions, you do not meet the eligibility criteria for Adams County Drug Court and will not be considered by the team for acceptance to the Adams County Drug Court, unless you take action to have the pending charges in another county disposed of within a reasonable amount of time of the referral to Drug Court or transferred to Drug Court.
