
Upon a motion by Bob Rhoades and second by Cathy Mitchel to approve Resolution 2024-3, amended meeting dates for 2024. Motion Carried.

Upon a motion by Fred Velez and second by John Summers to approve accepting the commissary report from Sheriff Dan Mawhorr. Motion Carried.


Fred Velez reported to Council members where IT is at currently with changing the domain name to .gov. He has spoken to IT Director, Mike Brown, regarding the project.
