There was discussion regarding a wage review meeting to discuss the possibility of two IT positions, Public Safety IT, and GIS Assistant. Nothing was approved at this time.


Mike Brown, IT Director, and Rick Burkhalter, Building and Grounds Manager, were present to discuss upcoming cybersecurity expenses the county may incur.
